Process

The Blog needs to be sent to TSE with the “Guest Blogger Terms and Guidelines”, this receipt accepts the blog terms and guidelines as defined by this document (also placed on the www.theseparationexchange.com).



TSE will notify you of the publishing details on our website and/or social media channels.

Blog Guidelines

- The length of the blog should be 500-700 words and submitted to us in Microsoft Word .doc or .docx format, via email with a copy of these terms and guidelines.
- Please include a bio, no more than 4 sentences. You may also include your social media links. The bio will appear at the bottom of the blog on our website. Please include an image of yourself. Image requirements: - Only images where you have permission to use commercially may be sent to us. Images must therefore either be your own, purchased or free stock
- It is your responsibility to ensure you have the applicable permissions from those who appear in the photograph

Terms

- Only Original content will be submitted (e.g. blog content has not been shared in any capacity through other channels elsewhere).
- The content must be written by you.
- The content cannot be submitted on behalf of someone else.
- The content must be sent by your email address to TSE, this invokes the acceptance of these blogging terms and conditions.
- TSE reserves the right to edit content sent to us if required.
- TSE reserves the right not to publish articles for any reason at our discretion without any explanation.
- TSE does not agree to pay you for the blog that you have written in any capacity.
- Unless agreed by TSE, the article may not be published on any other site/social media with the exception to sharing a link to the article from the TSE site or social media channels.
- TSE will select a date/time that is suitable for the blog publication to go live within our channels (TSE Site/Social media).
- TSE will decide if the images provided by you will be used within the blog, if you provide any images, it is your responsibility to ensure you have the applicable permissions from those who appear in the photograph. TSE may choose to replace any images provided by you as we deem appropriate.
- TSE reserves the right to publish/share the Blog via other media channels/publications once the blog has been submitted to us without any approval from you.
- By submitting a written piece to The Separation Exchange, in any format, including any text, images, graphics, or video, you agree that you have read and understood the terms outlined, allowing The Separation Exchange to publish and distribute submitted content to its audience via its websites, social media platforms and other 3rd party media platforms in perpetuity.
